A Banner Year for Educational Choice

merican families are emerging from the pandemic empowered with more educational choices than ever before. After more than a year of struggling with remote learning, many parents are seeking out alternatives such as private schools, charters, microschools, and homeschooling. In response to this demand, as of this writing, six brand new choice programs have passed in Arkansas, Indiana, Kentucky, Missouri, New Hampshire, and West Virginia. Another 14 existing programs have been expanded in 11 states, including a number in states where CSF partners operate:

New Hampshire: The New Hampshire legislature just passed a new education savings account (ESA) program, and Governor Sununu signed it into law as part of the new state budget. The new Education Freedom Accounts plan will allow families with incomes up to 300 percent of the poverty level to direct a portion of the funds spent by the state for their child's education to private school tuition, online learning programs, and other educational expenses as they choose. CSF already administers scholarships partly funded through the Granite State's Education Tax Credit program, and is gearing up to administer this new program, as well. In recent months, CSF assisted a coalition helping parents and the public understand how valuable the program would be.



A Banner Year for Educational Choice (cont.)

Missouri: A new Empowerment Scholarship Accounts program has passed both the state House and Senate and is waiting for the governor's signature. Under the program, donors to scholarship organizations would receive a tax credit for their contributions. CSF's St. Louis partner, the Today and Tomorrow Educational Foundation, is educating its families and other stakeholders about what this program could mean for thousands of needy families in the Show-Me State.

Montana: On the heels of the Supreme Court's Espinoza v. Montana Dept. of Revenue decision last June, the state's existing tax credit scholarship program has been greatly expanded, incentivizing donors to give much larger contributions for scholarships. Families using scholarships from CSF partner ACE Scholarships provided testimony to lawmakers about the value of being able to choose the best school for their needs.

Kansas: An existing tax credit scholarship program was expanded to remove a requirement that students must come from the 100 worstperforming schools and be in grades K-5. Now, low-income students in grades K-8 are eligible to apply. ACE Scholarships has been actively involved in grassroots efforts to connect parents with lawmakers through text and social media so they can make their voices heard.

Maryland: The BOOST voucher program has been expanded from \$6.5 million in scholarships to \$10 million. CSF Baltimore's staff and board have provided assistance to the program's administrators, drawing on their extensive experience managing scholarships.


